GM Report

Strategy: Strengthening regional promotion / marketing and event development, through story telling (what we do and why), communicating the benefit of the LCLC to the community, in turn measure and communicate the economic spin-off of the LCLC to the local region.

We began a campaign to solicit why our patrons love the LCLC and will fold that into more in-depth bio pieces on some of the people who come forward with compelling appreciation for the facility. We have been actively communicating the provincial health guidelines to prepare our users for vaccine status checking and marketing our new and existing program offerings

Strategy: Broaden the LCLC capacity to host a wide diversity of events by strengthening our collaboration with key partners and stakeholders. Prioritize variety of sport & entertainment activity within the facility.

The prospect for a Home and Waterfront Show in April is really taking shape. We have a rental inquiry for around New Years an all ages show. We thought we had Neptune Theater on the hook to do The Christmas Carole before their opening in Halifax but they pulled out.

Para Cup was canceled by Hockey Canada. We are in conversation with Team Canada to get them here for a training camp in November, there is a chance that a second international team may join them for the training camp and we could host 3-4 games.

Strategy: Collaborate with municipal partners to ensure that the LCLC becomes the hub for recreation promotion in the region.

Connect2Rec continues to gain momentum

Strategy: Add depth and variety to our program offerings with a focus on meeting user demand

New fall programs are gaining momentum

Strategy: Strengthen ways for the membership to recreate through outdoor opportunities in and around the LCLC.

Vaccine Checking-

General public has been understanding and compliant with the proof of vaccine requirements, we have a staff at the front entrance 8am to 8 pm checking vaccination status. The majority of the pushback was on social media and patrons in the facility are requiring support in accessing their info but are largely understanding of the requirement. For Jr. A games we have used 3 checker to deal with the increased traffic.

We are into week 3 of swim lessons, there were some withdrawals due to the vaccine requirements but the lessons are generally full and going well. We have a new Aquatic Supervisor and she is working to ensure the quality and consistency in that department. Autism Swims are resuming.
